

## The Valspar (UK) Corporation Limited ("Valspar")

### Love Your Colour Offer

If you purchase any 2.5L, 5L or 10L (any size combination up to ten (10) litres total in the same finish and colour) containers of **tinted/colour mixed** Eligible Valspar Product (as defined below) in a single transaction from a B&Q store ("Initial Valspar Product") and aren't satisfied with the colour, you can purchase from a B&Q store any other colour of the same Eligible Valspar Product in the same quantity as the Initial Valspar Purchase (the "Replacement Valspar Product") and then request a refund in the form of a bank transfer ("Refund") in an amount equal to the full purchase price of the Replacement Valspar Purchase ("the Offer").

The Offer is subject to the following terms:

- 1) The Offer is valid from 01.03.2019 until 30.09.2019.
- 2) "Eligible Valspar Product" means 2.5L, 5L or 10L containers of the following tinted/colour mixed products:
  - i. Valspar Premium v700 Wall and Ceiling Paint
  - ii. Valspar v500 Wall and Ceiling Paint
  - iii. Valspar v300 Wall and Ceiling Paint
  - iv. Valspar Kitchen and Bathroom Paint
  - v. Valspar Trade Walls and Ceiling Paint
  - vi. Valspar Exterior Masonry Paint
  - vii. Valspar Collections Paint (Pantone POP, Pantone Pastels, Bookcase, Out of this World, Cosmetic)
- 3) To request your Refund, follow these instructions:
  - (i) After trying your Initial Valspar Product on an interior/exterior wall and determining that you aren't satisfied with its colour, purchase within 60 days of the date on your Initial Valspar Product's receipt, the same volume (up to ten (10) litres total) in a single transaction of any other colour of the same Eligible Valspar Product at a B&Q store ("Replacement Valspar Products" as defined above).
  - (ii) Apply approximately 1mx1m of the Replacement Valspar Product on the same wall adjacent to the Initial Valspar Product.
  - (iii) Take a colour photograph showing the Initial Valspar Product and Replacement Valspar Product side by side on the wall (the "Wall Photo").
  - (iv) Fill out a Refund Request Form (available at [www.valsparpaint.co.uk/guarantee](http://www.valsparpaint.co.uk/guarantee)).
  - (v) Submit Refund Request Form online and Valspar will contact you via email within 48 hours with a claim number. Rebate Request must be submitted within 60 days of the date on your Replacement Valspar Product's receipt.
- 4) The Offer is valid only for purchases of Eligible Valspar Products.
- 5) The Initial Valspar Product and Replacement Valspar Product may not be purchased in the same transaction.
- 6) The Offer is open only to individual legal residents of the UK & ROI, who are aged 18 or over. The Offer is valid for individual consumers only and not for professional decorators or commercial projects. Refund Requests from groups/clubs/organizations won't be honoured.
- 7) Refunds will be paid as a bank transfer within 60 days of submitting the Refund Request Form. All Refund Requests are subject to verification by Valspar. Valspar's decisions regarding Refunds are final.
