### 1. THE OFFER

1.1 In order to qualify for this Promotion, participants must purchase new Fiskars branded products to the set values during the promotional period from participating retailers in the UK.

3/ All redemption claims must be submitted online and received between midnight on Wednesday 2<sup>nd</sup> May 2018 and midnight on Sunday 15th July 2018 inclusive.
